Dr. Billy Dodd wore many hats—physician, Society founder, leader, teacher, mentor, innovator, speaker, and—of course—jazz pianist. "While I never knew Billy Dodd well, I do remember his great performances on the piano during several annual meetings," says Paul Katz, MD, CMD, recipient of the 2018 William Dodd Founder's Award.

If you've been to a Society conference or read JAMDA or Caring, you know Dr. Katz. He is a popular presenter, a prolific author, and much in demand for interviews on a variety of topics. Dr. Katz served on the Society Board as president and, more recently, led the Foundation board as chair. In both of these roles, he provided exemplary leadership, played a strong role in strategic planning, and was a source of inspiration and innovation. At the same time, his work co-chairing the competencies curriculum has supported the organization mission and vision to include all practitioners who work in the post-acute space.
