Experiential Learning Hours Academic Calendar for 2024-2025

IMS students are required to complete a minimum of 64 Experiential Learning (EL) Hours each academic year (Fall, Spring, Summer). If you exceed the minimum EL hours during one academic year, you still must complete a minimum of 64 EL hours each academic year, even your last year. The minimum number of EL hour required for graduation is 256. But the average number of EL hours completed by students in the IMS program is closer to 600 EL hours.

Documenting EL hours: EL requests are to be submitted to the IMS database in advance or at the very beginning of each experience, for approval. After the experience, documentation and supervisor verification is required.

Students are strongly advised to complete EL hours every semester. If you are completing an average of 32 hours each fall and spring semester, that is only 2 hours per week. The summer is a good time to complete additional EL hours and engage in experiences that couldn't be done during the fall and spring. Complete EL hours all throughout the year, to be most competitive for professional schools, employment, and other post-graduation plans.

EL Activity Dates for the 2024-2025 Academic Calendar**

*Completion means that activities are finished and verified by a supervisor. EL hours are not considered complete in the IMS Database until they have been verified by a supervisor. Not meeting completion deadlines will result in an EL mapping hold. If students receive two consecutive EL mapping holds, they may be required to change their major out of IMS.

**Activity dates are the range of dates for EL hours each semester. Activity dates align EL hours with the academic semesters (fall, spring, summer). When submitting EL requests, you can only select one semester, and the range of dates need to fall within that semester. EL activities might span multiple semesters; in which case you will need to submit more than one EL request. One EL request cannot span multiple semesters. The last date for each semester is the Friday of finals week (see above chart). The following date starts the next semester.

***The deadline to have the minimum EL hours completed (verified by supervisor) for each academic year is the last day of the summer semester. **For the 2024-2025 academic year, the deadline date is Friday, August 1, 2025.** Hours must be completed by this date to avoid an off-track EL Mapping Hold.
