All proposal elements are due to our office ten (10) business days in advance so we can secure all COM approvals and help you assemble the complete proposal by the University's three (3) business days deadline for institutional approval. #### NIH: New Review Criteria for Research Project Applications Involving Clinical Trials

The National Institutes of Health (NIH) have released a notice to inform the community of additional review criteria that NIH will apply to clinical trial applications for research projects submitted to due dates on or after **January 25, 2018**. NIH is utilizing a multi-faceted approach to strengthen policies across the life cycle of a clinical trial, from development of the funding opportunity announcement (FOA), to the information collected in a grant application or contract proposal, to peer review of the application/proposal, and through to monitoring of the award. These actions include the implementation of new and more rigorous review criteria for evaluating clinical trial applications. Addressing these challenges will ensure the highest likelihood of translating research results into knowledge that will improve human health. [NOT-OD-17-118.](#)

#### NIH: Updates to Active Funding Opportunity Announcements to Prepare for Policy Changes

NIH has released a notice to inform the community that they will make a series of updates to existing funding opportunity announcements (FOAs) between **September 20** and **October 6, 2017** to prepare for grant application form and policy changes impacting applications for due dates on or after **January 25, 2018**. ### Congressionally Directed Medical Research Programs Funding for Fiscal Year 2017

The Fiscal Year 2017 Department of Defense Appropriations Act provides research funding for peer reviewed programs managed by the Department of Defense office of Congressionally Directed Medical Research Programs (CDMRP). Comprehensive Program Announcements will be released throughout 2017. The Program Announcements include detailed descriptions of funding mechanisms, evaluation criteria, submission requirements, and deadlines. All programs have a required Pre-Application. ### Bright Focus Foundation Alzheimer's Disease Research Program

The BrightFocus programs are designed to provide initial funding for highly innovative experimental ideas, including interdisciplinary investigations that may apply to two or three of the BrightFocus disease interests. Most of the awardees use the BrightFocus donor award money to demonstrate key findings that lead to later interest and additional funding from industrial or governmental funding agencies. BrightFocus accepts investigator initiated proposals related to developing treatments, preventions, and cures for glaucoma, macular degeneration, and Alzheimer's disease. ### PCORI: Pragmatic Clinical Studies to Evaluate Patient-Centered Outcomes - Cycle 3 2017

The Patient-Centered Outcomes Research Institute (PCORI) seeks to fund pragmatic clinical trials, large simple trials, or large-scale observational studies that compare two or more alternatives for addressing prevention, diagnosis, treatment, or management of a disease or symptom; improving healthcare system-level approaches to managing care; communicating or disseminating research results to patients, caregivers, or clinicians; or eliminating health or healthcare disparities. Proposed studies must address critical healthcare choices faced by patients, their caregivers, clinicians, or delivery systems. They must involve broadly representative patient populations and be large enough to provide precise estimates of hypothesized effectiveness differences and to support evaluation of potential differences in treatment effectiveness in patient subgroups. The letter of intent deadline is **October 31, 2017**. [More Information.](#)

### Foundation for Physical Medicine & Rehabilitation Mid-Career Research Grant 2017

The Foundation for Physical Medicine and Rehabilitation is requesting applications for its Mid-Career Investigator Research Grants program. One grant of \$20,000 will be made; it is to be used as seed money for new research projects that extend an established investigator's work in new directions. Award is a short-term grant for research in topics related to the field of physical medicine and rehabilitation. Preference will be given to projects that address the topics in their Research Priorities. The application deadline is **November 1, 2017**. [More Information.](#)

### Tourette Association of America Research Grants

Since the inception of its Research Grants and Fellowships Program in 1984, the Tourette Association has awarded more than \$21 million to 250 scientists working in basic scientific and clinical TS research. Projects funded by the organization have provided crucial insights into many areas of the disorder. Funding from the Tourette Association has also encouraged many investigators to become and/or remain involved in pursuing TS research. The Tourette Association funds basic and clinical research studies on all aspects of TS. Any study that has the potential to contribute to the treatment or understanding of TS will be considered. ### NSF Division of Molecular and Cellular Biosciences: Investigator-Initiated Research Projects

The Division of Molecular and Cellular Biosciences (MCB) supports quantitative, mechanistic, predictive, and theory-driven fundamental research designed to promote understanding of complex living systems at the molecular, subcellular, and cellular levels. While recognizing the need for thorough and accurate descriptions of biological complexes and pathways, the priority of the Division is to support work that advances the field by capturing the predictive power of mechanistic, quantitative, and evolutionary approaches. MCB is soliciting proposals in four core clusters: 1) Cellular Dynamics and Function, 2) Genetic Mechanisms, 3) Molecular Biophysics, and 4) Systems and Synthetic Biology. Typical research supported by MCB integrates theory and experimentation. Projects are particularly welcome that address the emerging areas of: multi-scale integration; transformative methods and resources (when driven by compelling biological questions); molecular and cellular evolution; the synthesis of life-like systems; and the quantitative prediction of the phenome from genomic information. ### Gerber Foundation Research Grants

The Gerber Foundation is accepting concept papers for health and/or nutrition-related research projects with the potential to have a significant impact on issues facing infants and young children from birth to three years of age. Grants of up to \$350,000 will be awarded for research projects focused on care provider issues that, when implemented, will improve the health, nutrition, and/or developmental outcomes for infants and young children. In particular, the foundation is looking for practical solutions that can be easily and rapidly implemented on a broad scale within a predictable time frame to clinical application. Major target areas for research include new diagnostic tools that may be more rapid, more specific, more sensitive, and less invasive; new treatment regimens that are improved or novel, less stressful or painful, more targeted, have fewer side effects, and provide optimal dosing; symptom relief; preventative measures; assessment of deficiencies or excesses (vitamins, minerals, drugs, etc.); and risk assessment tools or measures for environmental hazards, trauma, etc. Preference is given to projects offering a substantial promise of meaningful advances in the prevention and treatment of diseases and those with broad applicability to the general population on a regional or national level. ### Doris Duke Charitable Foundation Clinical Scientist Development Award

The Doris Duke Clinical Scientist Development Award provides grants to junior physician scientists to facilitate their transition to independent clinical research careers. Pre-proposal applications are being sought from junior physician-scientist faculty conducting clinical research in any disease area. Competitive applicants are expected to have research experience and publication records consistent with the rank of assistant professor. *In keeping with the wishes expressed in Doris Duke's will, experiments that use animals or primary tissues derived from animals will not be supported by this program.* Grants of up to \$495,000 over 3 years are available. ### Rivkin Center for Ovarian Cancer Pilot Study Program

The Rivkin Center for Ovarian Cancer is announcing funds for approximately twelve Pilot Study Program awards to be allocated based on scientific merit. One-year awards at \$75,000 each, Pilot Study Program awards will support investigator-initiated projects in all areas of ovarian cancer research. In addition, projects designed to analyze data from already funded clinical trials will be considered. Investigators at the assistant, associate or full professor level (or equivalent) are encouraged to apply. Funding priority will be given to proposals that are innovative, multidisciplinary, likely leading to submission of grant applications, and conveying translational research potential. From any on-campus computer, go to <http://pivot.cos.com>. FSU's IP addresses will be recognized by Pivot, so you can start searching for funding opportunities right away. Creating a Pivot account is easy—at the website, click “Sign up” in the upper right corner. Once registered, you can log in with a Pivot username and password anytime, anywhere. Logging in allows you to manage active or tracked funding opportunities, save searches, share opportunities, and search for potential collaborators. Username and password access is necessary when you are off-campus or when you want to save a funding record or funding search.

## SUBMITTING PROPOSALS FOR GRANTS AND CONTRACTS

### College of Medicine, Office of Research Administration (Med-RA)

**Help us help you!** The sooner you let us know of your intent to submit a proposal for extramural funding, the **sooner we can help you navigate** the paths to a successful submission. Our goals are to assist you with the CoM requirements and those of FSU Sponsored Research Administration (SRA), or in the case of private funding, the FSU Research Foundation (FSURF); minimize the administrative burden; and meet sponsor guidelines in a seamless, integrated fashion.

SRA/FSURF requires "complete" proposals three (3) business days in advance of the sponsor's deadline. *Please note that generally our office works on a first in, first out basis.* If you contact us at least 30 days in advance, together we can identify, gather, or create the elements/components, then assemble the application by the SRA/FSURF deadline for institutional approval. The goal is to have all the elements needed to assemble a complete proposal for SRA/FSURF no later than 10 business days before the sponsor's deadline.
