Medicare Coverage

- Medicare does provide financial assistance with tobacco cessation
- Up to 8 sessions in a 12 month period are covered
- As of March 2005, Medicare Part B coverage was expanded to include two new levels of smoking and tobacco cessation counseling—intermediate and intensive
- When billing for smoking and tobacco cessation counseling, use the following codes:

99406: Intermediate 3-10 minutes of counseling. Reimbursement rate: \$12.89

99407: Intensive greater than 10 minutes of counseling. Reimbursement rate: \$25.39

- The first 3 minutes (intermediate) of counseling is included in the standard E/M office visit
- Medicare Part D covers physicianprescribed nicotine replacement therapy which includes nasal spray, oral inhaler, bupropion and varenicline
- Over-the-counter treatments such as nicotine gum, nicotine patches and lozenge are not covered

Private Insurance

- Private insurance varies and patients should be advised to contact their private insurance companies to get more information
- Insured patients can take a more proactive approach to tobacco cessation treatment and counseling by being familiar with their coverage
- When plans do cover counseling, physicians can bill for it using the ICD-9 code for tobacco dependence, 305.1 (tobacco abuse)
- Include the appropriate CPT code for preventive medicine and counseling and risk factor reduction interventions services codes #99401-99404
- These codes are not to be used to report counseling and risk factor reduction involving patients with symptoms of established illness



Medicaid Coverage

- Medicaid patients who use tobacco products can obtain financial and medical assistance with tobacco cessation
- Florida provides coverage for the nicotine gum, nicotine patch, and bupropion
- Patients must get a prescription from their physician for these medications
- Unfortunately the lozenge, nasal spray, oral inhaler, and varenicline are not covered
